

COMMERCIAL PILOTS LICENCE (CPL)

CRICOS Course Code: 070430J (AVI40108 Certificate IV in Aviation Commercial Pilot Aeroplane Licence)



COURSE

Theory & Flying training is integrated under our CASA approval allowing you to complete the course faster.

PRE REQUISITES

- The successful completion of school year 12 or equivalent
- Be at least 18 years of age
- Competency in the English language or IELTS score of 6.0 or higher
- have a Class 1 CASA medical
- International students require an Australian Student Visa

SYLLABUS & OUTLINE

The AWA syllabus is made up of a minimum of 156 hours of flight training and covers all components required by CASA and includes;

- 92 hours dual instruction in a single engine aircraft
- 60 hours solo flight in a single engine aircraft
- 4 hours dual instruction in a synthetic trainer

MINIMA

156 hours is the minimum a student can do to obtain the Commercial Licence.

- Most students will take 10 to 15 hours more than this to achieve the required standard.
- To achieve the required CASA CPL standard, a student may be required to fly more than 156 hours. If additional hours are required to get the student to the required standard, the cost of the extra hours and landing charges will be charged to the student at published rates at the time.

GROUND SCHOOL

Full time theory classes and theory exams comprising;

- BAK course (2 weeks)
- PPL Theory (2 weeks)
- CPL Theory (10 weeks for the 7 subjects)

FLIGHT TESTS

There are three flight tests in the CPL Course.

- the GFPT (Student) licence test after approximately 35 hours of flight time to assess progress & ready the students for solo flying
- the PPL after approximately 65 hours (if the student elects to conduct a PPL as this is optional)
- the CPL after approximately 165 hours - refer to minima above

INCLUDES

All equipment and material needed to complete the course including text books, charts, maps, flight calculator, head set, etc.

- Air services charges, landing fees.
- Pre and post flight briefings.
- Test Fees for one attempt at each exam. If the student requires more than one test to pass any exam, the test fee for each additional test will be charged to students at published rates at the time.

ENDORSEMENTS & RATINGS

AWA offers a number of endorsements and ratings that enhance your Commercial Pilot Licence :-

A Night VFR Rating (NVFR) enables you to fly after sun down & carry passengers at night in VMC as Pilot-In-Command
Requirements; • Complete a minimum of 10 hours of night flying training and pass Flight NVFR Test

Constant Speed / Retractable Undercarriage Rating enables you to fly aircraft with retractable undercarriage and/or constant speed propeller. Aircraft with these attributes fly faster and more efficiently.
Requirements; • Complete 2 hours flying training in a single engine aircraft with CSU • Complete Cross Country exercise

Initial Multi Engine Endorsement enables you to step up into a more complex, high performance aircraft

Requirements; • 1 hour normal procedures & 1 hour asymmetric procedures upper-air work • 1 hour normal procedures & 2 hours asymmetric procedures circuit work • 5 pre/post briefings

Command Instrument Rating (Single and/or Twin)

Pre Requisites • Have 50 hours of cross-country command (PIC) flight time • Have 5 hours PIC at night

• Have passed IREX theory exam and have endorsement on aircraft in which training is conducted

Requirements • 15 hours in Dual Synthetic Trainer (Single) • 13 hours in Dual Synthetic Trainer (Twin)

- 20 hours Dual Instrument Flying Training in Synthetic Trainer
- 22 hours Dual Instrument Flying Training in Aircraft
- 10 pre/post briefings
- 20 pre/post briefings
